## Subject Matter/Remarks

He is in the concert promotion business and met CARL JOHNSON about fifteen to twenty years ago while in Austin, Texas. He knows CARL JOHNSON as C. J. PARKER and stated PARKER is the "King of Country [music] Porn" in Canada. BARRINGTON stated few people knew JOHNSON'S real name, saying most knew him as PARKER. Over the years, BARRINGTON stated JOHNSON occasionally stopped by to see him while in Tucson, with his most recent visit being in August 1998. Their visits generally involved conversations about music, although JOHNSON "rambled" about a lot of things. BARRINGTON stated he provided JOHNSON with limited help in his music career.

BARRINGTON stated that JOHNSON told him he was in trouble with the Royal Canadian Mounted Police (RCMP). JOHNSON stated he was given a Dog-at-Large citation and then failed to show up for a court hearing. JOHNSON stated things escalated and RCMP issued a warrant for his arrest.

BARRINGTON denied having any knowledge regarding threats JOHNSON made against any United States Judicial Officials, Internal Revenue Service employees or anyone else. He also denied having any knowledge of JOHNSON'S involvement in the bomb incident in Canada. Furthermore, BARRINGTON denied knowing or ever hearing the name "JIM BELL", "Assassination Politics", "Toto", or "Human Gus Peter". BARRINGTON stated the name "Truthmonger" is the "*Nom De Plume*" [pen name/pseudonym] JOHNSON is using for the book he is authoring; entitled *Space Aliens Ate My Drugs*.

BARRINGTON stated he has never seen JOHNSON act violent or espouse violence towards anyone. In addition, he stated he has never seen JOHNSON possess any explosive devices, chemical or biological agents. However, BARRINGTON stated that just before JOHNSON'S arrest in August 1998, in Tucson, Arizona, JOHNSON told him that he [JOHNSON] had attended a computer hacker's convention in Las Vegas, Nevada. While at the convention, JOHNSON stated he met "some guy" who possessed and showed him "nerve gas". JOHNSON did not describe the man or tell him the man's name. JOHNSON stated he was eventually "thrown out" of the convention, but did not say why.

BARRINGTON stated he did not let JOHNSON use any of his computer equipment. BARRINGTON stated the only items he had that belong to JOHNSON are his pickup truck, which he took custody of upon JOHNSON'S arrest, and some original musical CD's that JOHNSON made. BARRINGTON stated he did not possess any other property, including writings or computer related software or hardware that belonged to JOHNSON.
