1. I operate only one "Cypherpunks Internet Mailing List." The technical name for this list is "cypherpunks-unedited" (hereinafter the "List"). As to its "physical operation," the List operates more or less like other mailing lists on the Internet. People subscribe to the List by sending the phrase "subscribe cypherpunks-unedited" to the List's automated software robot at its e-mail address "majordomo@toad.com." E-mail is an electronic message sent over the Internet from one computer to another. In general, all subscribers receive all e-
