INTERVIEW OF SUBJECT

ON 07/27/98, SA SHERIDAN AND I INTERVIEWED THE SUBJECT AT [REDACTED] TUCSON, ARIZONA. THE SUBJECT WAS SITTING IN A BACK ROOM IN HIS UNDERSHORTS WHEN CONTACTED. THE SUBJECT APPEARED ORIENTED AS TO TIME, PLACE, AND DATE.

SA SHERIDAN OBTAINED BIOGRAPHICAL DATA.

THE SUBJECT ADVISED HE HAS BEEN DIAGNOSED AS SUFFERING FROM SCHIZOPHRENIA, BIPOLAR AFFECTIVE DISORDER AND TOURETT'S SYNDROME. HE STATED HE WAS DIAGNOSED AT A YOUNG AGE (19 YEARS), AND WAS TREATED MOSTLY IN CANADA. HE DID NOT PROVIDE SPECIFICS REGARDING HIS TREATING PHYSICIAN OR FACILITIES WHERE HE RECEIVED TREATMENT. HE ADVISED HIS DOCTOR HAS PRESCRIBED PROZAC, RITILIN, AND RESPIRADOL TO TREAT HIS CONDITION.

SA SHERIDAN ORALLY ADVISED THE SUBJECT OF THE NATURE OF THIS INVESTIGATION AND HIS RIGHTS PER SSF-1737 (MIRANDA WARNING). THE SUBJECT ORALLY ACKNOWLEDGED AND WAIVED HIS RIGHTS AND AGREED TO BE INTERVIEWED.

I SHOWED THE SUBJECT A PHOTOCOPY OF A COMPUTER MESSAGE ENTITLED "OFFICIAL PHYSICAL DEATH THREAT". HE REVIEWED THE MESSAGE AND STATED "IT LOOKS LIKE MY STUFF". WHEN ASKED ABOUT HIS REFERENCE TO THE PRESIDENT IN THIS COMMUNICATION, THE SUBJECT CLAIMED HE WAS TALKING IN VIRTUAL TERMS AND NOT MEATSPACE TERMS. THE SUBJECT RAMBLED ABOUT HIS RIGHTS BEING TRAMPLED BY OTHER LAW ENFORCEMENT AGENCIES, HIS COMPUTER BEING SEIZED, AND HIS FREEDOM OF SPEECH RIGHTS. THE SUBJECT STATED JOHN GILMORE IS AN ALIAS HE USES.

I ASKED THE SUBJECT IF HE WAS AWARE IT WAS AGAINST THE LAW TO THREATEN THE PRESIDENT. HE REPLIED "NO". I ASKED HIM IF HE INTENDED TO HARM THE PRESIDENT OR ANY OTHER GOVERNMENT OFFICIAL, TO WHICH HE REPLIED "NO, FUCK NO". HE RAMBLED THAT HE DOESN'T MEAN TO HARM ANYONE; HE USES THE INTERNET TO WRITE ARTICLES, VOICE OPINIONS, AND FOR POLITICAL COMMENTARY. HE STATED HE LIVES ON THE COMPUTER AND DISTRUSTS "BIG BROTHER" LIMITING PEOPLE ON THE INTERNET.

THE SUBJECT STATED HE IS CURRENTLY WRITING "SPACE ALIENS HID MY DRUGS" (SAHMD), WHICH HE DISTRIBUTED ON THE INTERNET. HE ALSO ADMITTED WRITING [REDACTED]. THE SUBJECT ALLUDED TO BEING A COUNTRY [REDACTED] SINGER AND SONGWRITER.

THE SUBJECT ADMITTED USING LINDA LOU REED'S E-MAIL ADDRESS AT PIMA COMMUNITY COLLEGE TO SEND THE [REDACTED] MESSAGE. HE STATED REED WAS UNAWARE OF HIM USING HER COMPUTER TO SEND SUBJECT MESSAGES ON THE INTERNET.

I SHOWED THE SUBJECT A PHOTOCOPY OF A COMPUTER MESSAGE ENTITLED "WANTED DEAD OR ALIVE". HE REVIEWED THE MESSAGE AND ADMITTED AUTHORIZING THIS MESSAGE. HE EXPLAINED HE WAS PISSED OFF AT THE ROYAL CANADIAN MOUNTED POLICE FOR STEALING HIS COMPUTER. HE SAID DUMB COPS COME IN AND FORCE SITUATIONS WITH HEAVY-HANDED TACTICS INSTEAD OF TALKING. "DUMB COPS IS WHAT SCARES ME" SAID THE SUBJECT.

I SHOWED THE SUBJECT A PHOTOCOPY OF A COMPUTER MESSAGE ENTITLED "THE OFFICIAL RCMP HATE PAGE". AFTER REVIEWING THIS DOCUMENT, HE ADMITTED AUTHORIZING IT.

THE SUBJECT STATED TOTO AND THE TRUTHMONGER ARE ALIASES HE USES IN HIS WRITINGS, AND A COUPLE OF HIS MONIKERS ON THE INTERNET.

I TALKED WITH THE SUBJECT ABOUT HIS VIEWS ON CONFRONTATION. HE STATED HE TRIES TO DIFFUSE CONFRONTATIONS, AND A SECOND OPTION IS TO GET THE FUCK OUT OF THERE. HE CLAIMED HIS MEDICATIONS AMELIORATE HIS RAGE ATTACKS FROM TOURETT'S SYNDROME. HE TOLD ME HE HAS LIVED WITH HIS ILLNESS A LONG TIME AND THAT HE TRIES TO MONITOR HIS BEHAVIOR BY NOT DRIVING ON "BAD DAYS", AND NOT OWNING FIREARMS.

I ASKED THE SUBJECT ABOUT MAKING BOMBS. HE STATED HE'S MADE A LOT OF NUCLEAR SUITCASE BOMBS. HE EXPLAINED HE NEEDED HEAVY METAL FOR PLUTONIUM SO HE TOOK A "METALLICA" TAPE AND PUT IT INTO A JAR OF WATER IN A CASE. HE MADE REFERENCE TO DOING A HARMFUL BOMB WITH A FELLA FROM THE OLD DAYS BUT DID NOT COMMENT FURTHER.

REGARDING TRAVEL, THE SUBJECT REPORTED TRAVEL IN CALIFORNIA, ARIZONA, WEST TEXAS, AND CANADA. HE CLAIMED HE USES HIS TRUCK TO GET AROUND. HE DENIED ANY TRAVEL TO OR INTENTION TO TRAVEL TO WASHINGTON, DC.

REGARDING SOURCES OF INCOME, THE SUBJECT NAMED HIS FATHER AS HIS ONLY CONSISTENT SOURCE OF INCOME.

I ASKED THE SUBJECT HIS FEELINGS REGARDING THE RECENT SHOOTING SPREE AT THE U.S. CAPITOL. HE EXPRESSED SYMPATHY FOR THE POLICEMEN KILLED AND BYSTANDER WOUNDED THERE.

THE SUBJECT REITERATED HE DID NOT INTEND TO HARM THE PRESIDENT OR ANYONE. HE ALLUDED TO THE PROTEST OF THE BOSTON TEA PARTY, AND THE RIGHT TO PROTEST AGAINST THE GOVERNMENT. HE STATED HIS WRITING WAS (WARPED) HUMOR, AND PERSONAL POLITICAL COMMENTARY AND WAS NOT INTENDED TO BE CARRIED OUT.

I ADVISED THE SUBJECT OF THE LAWS PROTECTING THE PRESIDENT AND VICE PRESIDENT FROM THREATENING COMMUNICATION, AND THE PENALTIES FOR VIOLATION OF SAID LAWS. THE SUBJECT ASSURED ME HE WOULD REVIEW HIS WRITINGS IN THE FUTURE WITH RESPECT TO THREATENING OFFICIALS PROTECTED BY THIS SERVICE.

THE SUBJECT PROVIDED HANDWRITING EXEMPLARS AND PHOTOGRAPHS. I ASKED THE SUBJECT FOR PERMISSION TO SEARCH HIS TRUCK FOR WEAPONS OR THREATENING COMMUNICATIONS. HE ORALLY PROVIDED CONSENT TO SEARCH SUBJECT VEHICLE, A WHITE MAZDA TRUCK BEARING CANADIAN (SASKATCHEWAN) PLATE NUMBER AAF-746. SA SHERIDAN AND I SEARCHED THE VEHICLE WITH NEGATIVE RESULTS.

THE INTERVIEW TERMINATED WITHOUT INCIDENT.
