Internal Revenue Service Inspector Jeff Gordon, stationed in Portland Oregon, called to ask for assistance with one of their cases. He wanted to verify the identity of a CARL E. JOHNSON. CARL E. JOHNSON planted a bomb in a federal court house, threatened to kill Internal Revenue Service employees, threatened to kill Federal judges, and threatened The President of the United States. He later planted a bomb in Canada and fled to the United States. He was arrested in Tucson Arizona where when questioned by Secret Service Agents, he gave them a false name and Social Security Number. He is currently in Federal custody in Tucson Arizona.

The Office of the Inspector General, Office of Investigations, has searched and reviewed the Social Security Administration computerized records concerning CARL E. JOHNSON and the Social Security Numbers 456-45-0297 and 608-33-5345.

A review of the records revealed in February 1979, C.J. PARKER, also providing the second name CARL E. JOHNSON, date of birth May 6, 1949, filed for and was assigned Social Security Number 456-45-0297 by the Commissioner of the Social Security Administration. In September 1980, C.J. PARKER also providing the second name CARL E. JOHNSON, completed an additional application for a replacement Social Security Number card for 456-45-0297. He completed no additional Social Security card applications for this number.

A review of the records revealed the Social Security Number 608-33-5345 is not assigned to CARL E. JOHNSON. This number is an invalid number that has never been issued by the Commissioner of the Social Security Administration.
